- **Timber Pest Management** (2 units)
- Allows you to add Timber Pests to your existing Pest Management Technician Licence.**
- **CPP30119 Certificate III in Urban Pest Management** (10 units)
- Includes all units from both General Pest and Timber, plus 5 additional non-licensing units. Candidates must be employed in the industry. Those who already completed the pest and termite units can upgrade by completing the remaining 5 units.**
- **Install Termite Management Systems** (1 unit)
- Qualifies you to install termite management systems during pre-construction. **




